

### ORDER

In exercise of the powers conferred by Section 22 of the Central Administrative Tribunal Act, 1985 (Central Act 13 of 1985), the Central Administrative Tribunal makes the following amendment in Rule (4) of the Central Administrative Tribunal Rules of Practice, 1993.

### CHAPTER III

### PREPARATION AND PRESENTATION OF PLEADINGS AND OTHER PAPERS

#### 4. Preparation of pleadings and other papers:-

- (a) All pleadings, affidavits, memoranda and other papers filed in the Tribunal shall be fairly and legibly typewritten or printed in English or Hindi language on durable white foolscap folio paper of Legal size (36 cms. Long and 22 cms. wide) on one side only in double space with a left margin of 5 cms. and right margin of 2.5 cms. duly paginated, indexed and stitched together in the paper book form. The index shall be in Form No. 1.
